## Admission and registration

the 3 libraries of the Côte d'Azur observatory (OCA) are accessible by appointment for members of the Côte d'Azur university (UCA)

Prior registration separate from the UCA university libraries is required in order to be able to borrow documents.

Registration is free and valid for 1 year or the duration of the stay if it is less than one year.

It permits to :

- consult documents on site ;
- reserve and borrow documents from any OCA library ;
- access personalized services (search assistance, alerts, etc.).

## Loan policy

Library borrower is responsible for library materials checked out under his/her name, and for returning items in due time. If an item is damaged or lost, borrower must replace or reimburse it at the actual cost.

## The borrowing and renewing rights

Borrowing : 3 items for 35 days  
Renewing : 7 days

Journals, reference books and historic collections do not circulate .

## Return of documents

The documents must imperatively be returned to one of the 3 libraries of the Côte d'Azur Observatory (OCA).
